Approval by the Director of Neighbourhood Resources and Development, in conjunction with the undernoted, is requested for grant applications from the undernoted so urgent works can be progressed.

- Mid Craigie/Linlathen Keep Fit Group - the value of £790. This grant is to meet the cost of providing a free creche for the participants in the keep fit group at Brooksbank Neighbourhood Centre.
- Happyhillock Child and Family Centre (PALS Group) - to the value of £442. This grant is for the cost of providing trips for children and families at the Centre.
- Hub and Brooksbank Management Committee - to the value of £1,000. This grant is to meet costs associated with a summer programme at Hub and Brooksbank Centres; costs for activity programme and specialist staff.
- Khawateen (Asian Women's Group) - to the value of £1,026. This grant is to meet costs associated with an educational trip to the Isle of Lewis for a group of 14 women who won the Adult Learners' Week National Award in May 2001. The women are members of ESOL group (English for Speakers of Other Languages).
- St Kildas Baptist Church Parent/Carer Children's Group- to the value of £1,900. This grant is to meet costs associated with the establishment of a Parent/Carer's children's group in St Marys. There is no other under 5's provision in the St Marys area. Costs include heat, light, safety equipment, summer outings, equipment.
- Middleton Community Woodlands - to the value of £630. This grant is to meet costs of a community open day at Middleton Community Wood to celebrate the completion of Paths For All Scheme and to encourage environmental education. Costs include Woodland Crafts (one day) and refreshments. The event will be held in September 2001.
- Whitfield Activity Complex Ltd - to the value of £2,500. This grant is towards the cost of the annual Whitfest Event. Costs include musicians and professional artists fees, promotional materials, art materials, administration etc.
- Charleston Neighbourhood Centre Management Committee - to the value of £2,275. This grant is to meet costs associated with a holiday activity programme for 5-16 year olds during July and August. The costs include Play Scheme Co-ordinator, sessional staff, activities etc.
- Stobswell Youth Issues Group - to the value of £2,267. This grant is to meet the cost of a children's summer activity programme in the Stobswell area. Costs include staffing, accommodation, resources, transport etc.
- Ormiston Community Lounge - to the value of £5,491. This grant will meet staff costs at the Lounge to secure continuation of services until 31 August 2001.
