#### 1.0 PURPOSE OF REPORT

1.0 This report outlines proposed funding allocations to Dundee Partnership projects for the financial year 2020/21.

#### 2.0 **RECOMMENDATIONS**

2.1 It is recommended that Committee approves the allocations of funding to the organisations/projects set out in Appendix 1 for 2020/21.

#### 3.0 FINANCIAL IMPLICATIONS

3.1 For financial year 2020/21 it is proposed to allocate grants amounting to £582,703. These proposals represent a saving of £30,000.

#### 4.0 BACKGROUND

- 4.1 Following the mainstreaming of the Scottish Government's Fairer Scotland Fund, the projects supported by the Dundee Partnership have largely been consolidated across council services over subsequent years. A small number continue to be managed by the Chief Executive's Service due to their relationship to the Fairness strategy, anti-poverty and regeneration work. A summary of the services to be provided by these projects and organisations is outlined in Appendix 1.
- 4.2 These projects were the subject of a council-wide report to Policy and Resources Committee in February 2019 where a 5% reduction for all third sector projects was agreed. (Article II of the Minute of Meeting of the Policy and Resources Committee of 21 February 2019, Report No 92-2019 refers.) The same report proposed that officers should review funding to ensure that best value is being achieved and that the outcomes being delivered are closely aligned with Council and City Plan priorities.
- 4.3 Following this review, it is proposed that funding to four projects remain unchanged for 2020/21 as follows:

Save by the Bell, Hillcrest Futures Project, Dundee Energy and Efficiency Project and Leisure and Culture Dundee – Youth Sport Development.

- 4.4 In recent years, the financial stability of Discovery Credit Union has improved, and it is clear that the service no longer requires the previous level of funding. The most recent accounts available for DCU also show that they are only £12,000 from breaking even based solely on the income they generate through lending to their members. They also still hold approximately £20,000 received previously from the Council for underwriting bad debt associated with low cost loans. For 2020/21, an allocation of £24,504 will enable DCU to maintain additional activity delivered thanks to funding from the Council.
- 4.5 The Board of Dundee North Law Centre is currently looking into a number of changes that should help to modernise the project. These aim to achieve an increase in Scottish Legal Aid Board revenue and/or a reduction in the staffing complement. Based on these anticipated improvements, a 4% saving is proposed. An allocation for 2020/21 of £150,304 will enable Dundee North Law Centre to continue to provide free legal advice, assistance and representation to individuals living in community regeneration areas.

#### 5.0 POLICY IMPLICATIONS

- 5.1 This report has been subject to an assessment of any impacts on Equality & Diversity, Fairness & Poverty, Environment and Corporate Risk. A copy of the Integrated Impact Assessment is attached to this report.
- 5.2 Due to impressive improvements in financial performance at Discovery Credit Union and measures to increase external funding to Dundee North Law Centre, it is anticipated that there will be little or no impact on project delivery and access as a result of proposed savings.

# Fairness and Poverty Implications:

The small reduction in funding to Dundee North Law Centre may impact slightly upon the project's overall capacity to deliver benefit and housing related advice.

Similarly the reduction in funding to Discovery Credit Union may impact on their ability to offer lower cost loans to their members, potentially resulting in higher costs to access their products.

## **Proposed Mitigating Actions:**

The Board of DNLC are currently looking into a number of changes that should help to modernise the project. When these changes are brought in, it could be expected that there will be an increase in Scottish Legal Aid Board revenue, savings made to the project running costs, and/or a reduction in the needed staffing complement. Any or all of these would offset the proposed reduction in funding.

The most recent accounts available for Discovery Credit Union show that they hold approximately £20,000 from previous DCC funding for the underwriting of bad debts. The same accounts also showed DCU able to add to their financial reserves. On this basis, it is likely that the reduction in funding will have little or no impact on project delivery and access to their low cost loans by members from our most deprived areas. The Dundee Partnership Team will continue to monitor the project in order to determine whether any change in the affordability / accessibility of low cost loans takes place.
