# <u>DUNDEE CITY COUNCIL (EARLSTON AVENUE/WHITFIELD AREAS, DUNDEE) (20 MPH</u> ZONES) ORDER 2025

Dundee City Council in exercise of the powers conferred on them by Section 84 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the said Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- This Order may be cited as Dundee City Council (Earlston Avenue/Whitfield Areas, Dundee) (20 mph Zones) Order 2025 and shall come into operation on the Thirty First day of March Two Thousand and Twenty Five.
- 2. No person shall drive a motor vehicle on any lengths of roads specified in the Schedule to this Order at a speed exceeding 20 miles per hour.
