#### 2. Previous Minutes & Matters Arising

#### Typos noted and corrected

Meeting with School and family development workers did not progress to any holiday provision due to staff shortages and limited hours.

However, engagement with school staff has led to the implementation of a Family After School Club in June

#### 3. LCPP Review

Discussion about representation at the partnership, with it being suggested that all departments of DCC provide a named person and a depute to attend

Attendance has been low at meetings, and it was noted that this is often dependent on the individual and their commitment to the partnership and often, when people leave or move to another post there is no further input.

Venue and times of meeting will also require a review

Fraser will speak to someone form a sheltered housing complex for representation

Christine is planning to contact all on the mailing list to confirm they are still an appropriate contact and if they wish to remain on the list

Having a presence in the Ward was also discussed, Christine is in negotiation with the gate church to be based there one morning a week and The Friary has kindly offered a room on Wednesday afternoons. It was agreed that this will be beneficial for the partnership

Ryehill Police Station was also raised as a possible shared workspace, Fraser will speak to Police Scotland as this has previously been discussed as part of Police Scottland's property rationalisation

Christine will contact groups within key themes in the plan to ensure they are still relevant
