## **1.0 PURPOSE OF REPORT**

This report updates on the progress made towards meeting the commitments set out in the Council's first British Sign Language (BSL) Local Plan 2018-24 published in September 2018.

## **2.0 RECOMMENDATIONS**

It is recommended that Committee notes the content of the Progress Report and approves the revised action due dates in Appendix 1.

## **4.0 BACKGROUND**

4.1 The BSL (Scotland) Act 2015 places a legal requirement on the Scottish Government to produce a National BSL Plan every 6 Years and an Interim Progress Report every 3 years. The [Progress Report](#) was due to be published in October 2020. However, this was delayed due to the COVID Pandemic and was published on 27 October 2021

4.2 The Act also requires Public Authorities to publish their own Local Plan every 6 years which demonstrates how they will work towards implementing the National Plan in their areas and report on progress made every 3 years.

4.3 The Scottish Government published the British Sign Language (BSL) National Plan 2017-2023 in October 2017. The National Plan lists 70 actions which will help the Scottish Government to achieve an agreed 10 long term goals areas:

- What we'll do across all of our services
- Family Support, Learning and Childcare
- School Education
- Post School Education
- Training, Work and Social Security
- Health (inc. Social Care), Mental health & Wellbeing
- Transport
- Culture and the Arts
- Justice
- Democracy

## **5.0 DUNDEE CITY COUNCIL'S LOCAL PLAN DEVELOPMENT & DELIVERY PROGRESS**

5.1 In October 2018 the Council developed a 2018-2024 Local Plan with goals framed in-line with the Scottish Government's National Plan. The plan also ensures equal access to services and support for services by BSL Users. The Council highlighted the following key priorities:

- Ensuring services and the information provided to customers are accessible to BSL users

- Ensuring the principles and outcomes of 'Getting it right for every child' are delivered for all D/deaf or deafblind children and young people and ensuring their families are able to access support when required
- Supporting BSL communities to access jobs, education or training to ensure that they are not left behind economically
- Providing support to BSL users to take part in the breadth of leisure and culture offerings across the city and to share their own BSL & Deaf culture
- Ensuring BSL users can access mental health & wellbeing services when required
- Encouraging BSL users to engage and become involved in the democratic and public life aspects of the city

5.2 The Local Plan was finalised after consultation with BSL users and sensory services in Dundee and Tayside. On 24 September 2018, Committee approved the Council's first BSL Local Plan 2018-24 (Article vii of the Minute of the Policy & Resources Committee on 24 September 2018, refers). The Council remains committed to continuing to engage with BSL users and work in partnership as appropriate during the implementation, delivery, monitoring and review of the plan and services.

5.3 As a result of the Pandemic, the Scottish Government did not publish their Progress Report in October 2020 as intended but published it on 27 October 2021. In line with this, the Council has reviewed and revised the target dates originally put forward in its Local Plan. The Council has consulted with appropriate stakeholders and agreement has been reached that the original actions put forward in the Local Plan remain appropriate and progress will be monitored and reported on throughout the remainder of the plan.

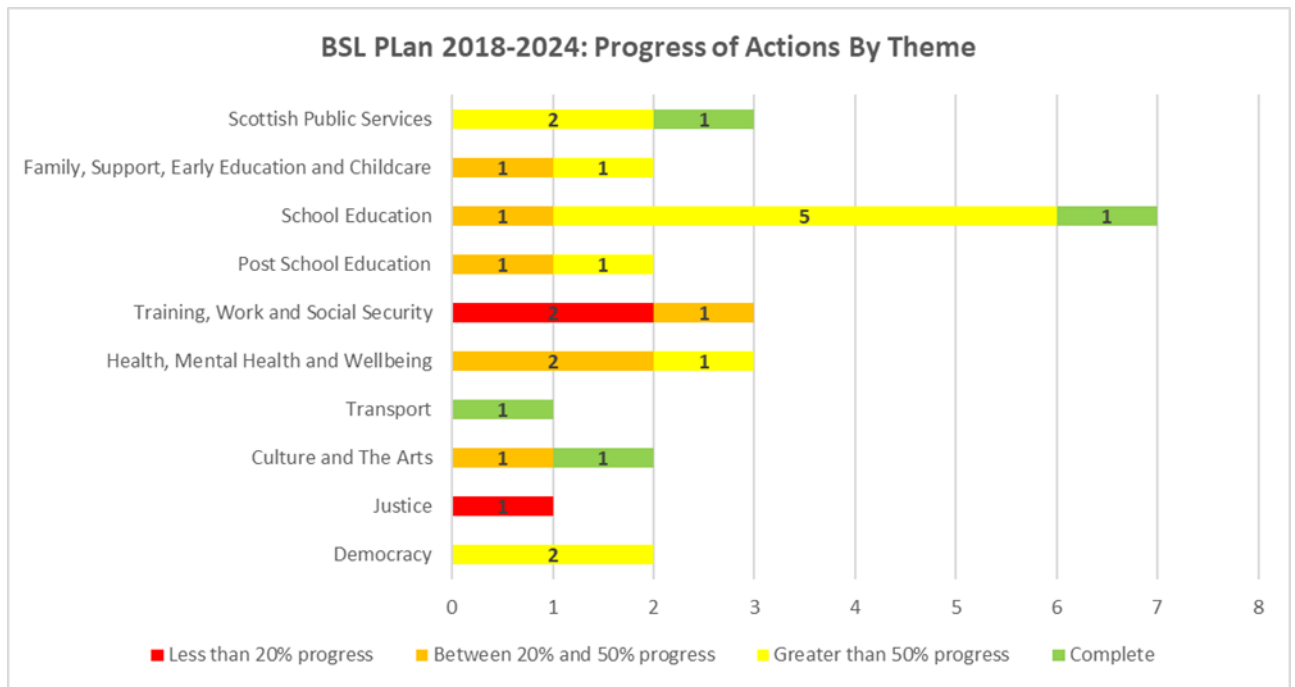
5.4 Despite the challenges of the pandemic, the Council has continued to make significant progress in achieving its priority commitments and in working towards Scottish Government's long-term goal areas. This has been evidenced, through the Council's contribution to the British Deaf Association (BDA) [National Progress Report](#) published in October 2021 which, in turn, will help to shape future Scottish Government BSL work.

## 6.0 **DUNDEE CITY COUNCIL'S BSL PLAN: PROGRESS MADE IN PRIORITY AREAS**

6.1 The actions contained in the Dundee City Council BSL Plan 2018-2024 are in-line with the Scottish Government's long-term goals areas:

- Scottish Public Services
- Family, Support, Early Education and Childcare
- School Education
- Post School Education
- Training, Work and Social Security
- Health, Mental Health and Wellbeing
- Transport
- Culture and The Arts
- Justice
- Democracy

6.2 The chart below shows the current status of the actions contained in the plan. A detailed summary of each action including the percentage complete along with an update detailing the work undertaken to progress the action can be found in Appendix 1.



**6.3** Despite the challenges faced as a result of the Pandemic, ongoing work towards the Council's priority commitments led to meaningful progress over the last 3 years. Examples include:

**a) Dundee City Council Website:**

A key area of focus has been to improve the accessibility of the Council's website for BSL Users. This has been achieved as a result of feedback and input received from the British Deaf Association and other local BSL user groups' including North-East Sensory Service, Deaf Action & Deaf Links as well as individual services users who all highlighted the need for more accessible information.

Based on this feedback, the Council embedded the [BSL Service User's Search Function](#) and provided information about [Key Services](#) and updates on [Covid support](#) in BSL on the Council Website.

**b) Dundee House**

Contact Scotland BSL app has been made available in Dundee House reception. This enables BSL Users to have their query dealt with at the first point of contact

**c) The Accessibility and Inclusion Service**

This service provided support to children and families across Dundee school/nursery communities over the past two years:

- 150 children and young people who are Deaf have been supported to access both remote and in-person learning with either BSL or other interpretation and adaptations
- Children and young people with a visual impairment have received technological and teaching support to access learning
- For those sitting SQA assessments/exams, arrangements were put in place for reader, scribe and use of ICT.

**d) Community Engagement**

The Council participated in various stakeholder and partnership consultations and events with NHS Tayside, Angus Council, Perth & Kinross Council and the Dundee Health and Social Care Partnership to raise awareness of BSL.

The Council has had a number of engagements with Deaf young people, especially with activists aged between 12-15 years old who were given a voice about the Council services which have been considered

Although, engagement work has been maintained, the Pandemic and previous lockdown conditions have limited the extent to which the Council has been able to engage directly with the BSL Community. Nevertheless, during the second half of 2020, a number of online discussions were held with local third sector agencies whose main client groups include a majority of people with one or more protected characteristic. These included North East Sensory Service, Deaf Action & Deaf Links.

The Council has recently appointed a new Equality & Fairness Officer, who is tasked with progressing BSL activities.

#### **e) Staff Development**

The Council offers a sensory impairment e-learning module to all employees. This e-module includes basic BSL. 326 employees have completed this e-module since August 2019. The Council has also funded accredited BSL qualifications within Education. In addition, the Council has also worked closely with the Health & Social Care Partnership to encourage and support its workforce to attend Contact SCOTLAND-BSL awareness raising sessions online and face-to-face.

#### **f) Access to Leisure and Culture**

The Council has worked jointly in partnership with Leisure and Culture Dundee to offer successful BSL tours and other activities at some of the city's local attractions; For instance, signing choir and V&A BSL tours.

#### **g) Social Enterprise**

Six Deaf young people based in Dundee have been trained in professional BSL presentation skills and they will be given the opportunity to present a series of BSL videos to explain to the Deaf community how to access council services and supports using ContactSCOTLAND-BSL service as part of a new BSL social enterprise.

#### **h) Collaboration with Dundee Health & Social Care Partnership**

Through working closely with the Dundee Health & Social Care Partnership the Council has actively disseminated, shared and signposted people to accessible information through the DHSCP, NHS Tayside and internal channels (in foreign languages as well as BSL and easy read information); shared accessible key information online about the Pandemic; created Blue Badge Information in BSL; provided interpretation and translation and other communication supports when people need these to access services; contracted Social Work and Specialist Equipment Service for people with Sensory needs.

Covid information and links (especially those from NHS Inform) will continue to be shared through these services through electronic links and videos, paper copies and face-to-face. Other Health and Social Care information in BSL is shared when it is available and SEEHEAR funding was allocated last year to provide BSL information on the webpages of some of our partner agencies.
