NOTES

1. In addition to the candidate, the election agent and the candidate's guest, 30 COUNTING AGENTS may be appointed to attend the counting of the votes for the above Constituency.
2. In addition to the candidate and election agent, POLLING AGENTS may be appointed to attend in each polling station in the constituency. While there is no restriction on the TOTAL number of polling agents who may be appointed, not more than one polling agent may be admitted at the same time to a polling station on behalf of the same candidate.
3. The names and addresses of the candidate, candidate's guest, election agent and counting agents should be typed or written in block capitals commencing on page 2.
4. The names and addresses of the candidate, candidate's guest, election agent and polling agents should be typed or written in block capitals commencing on page 4.
5. Those appointed as polling agents may also be appointed as counting agents.
6. The candidate, candidate's guest, the election agent and the counting agents must be given by the Returning Officer a copy in writing of the provisions of Subsections (2), (4) and (6) of Section 66 of the Representation of the People Act 1983, as amended. This will be enclosed with the admission passes.
7. The candidate, candidate's guest, the election agent and the polling agents must be given by the Returning Officer a copy in writing of the provisions of Subsections (1), (3), (5) and (6) of Section 66 of the Representation of the People Act, 1983, as amended. This will be enclosed with the admission passes.
8. This form duly completed must be lodged with the Returning Officer at the Election Office (address) on or before 5.00 pm on 5 December 2019.
